## The Hangar at Pathways Church House Rules

**Mission Statement:** The Hangar is a free after school hangout provided by Pathways Church. A place where we can build significant relationships with students and build foundations in Christ in an ever changing world.

**Ages Served:** You must be enrolled in 6<sup>th</sup>-12<sup>th</sup> grade to attend the Hangar at Pathways Church.

**Inclement Weather:** The Hangar at Pathways Church will follow the decisions of the Sevier County School District. Please watch the official social media pages for details.

**Program Fees:** The Hangar at Pathways Church is free to the public. However, there will be fees for special events, late pickups, snacks, etc.

**Leaving the Hangar:** Students will not leave the Hangar without written permission from a legal parent or guardian.

**Late Fees:** The Hangar at Pathways Church will charge a late fee of \$50 per child for waiting by staff longer than 30 minutes beyond closing time. After one hour and all attempts to make contact are exhausted we will call the police to assist. Late fees must be paid before a student may return to the Hangar.

**Behavior and Guidance:** The Hangar at Pathways Church, staff, and volunteers will use means to resolve conflict. However, if a student continues to disregard the house rules they may be subject to suspension of Hangar activities for a set period of time or indefinitely.

**Dress Code:** The Hangar at Pathways Church reserves the right to determine appropriate attire to attend the Hangar and participate in additional activities. We encourage students to follow the dress code of the Sevier County School District.

**Personal Belongings:** There are designated areas to store personal belongings but the Hangar is not in any way responsible for lost, stolen, or broken items. "The best policy is to not bring anything you cannot afford to lose." No weapons, including pocketknives are allowed on property.

**Damages:** Students will be charged for any damages they are responsible for to the building, equipment, etc. All fees must be paid before a student may return to the Hangar.

**Drug, Alcohol and Tobacco:** The Hangar at Pathways Church will not tolerate the use of drugs, alcohol, vaping products, or tobacco on property.

I have read the house rules above and understand that any violence, inappropriate language and/or activities that do not line up with Pathways Church standards will not be tolerated. I will obey and respect the staff, volunteers, and other students of The Hangar at Pathways Church. I understand that disregarding any of these rules could result in punishment including being expelled from The Hangar at Pathways Church indefinitely.
